Stakeholder Information Session

FEMA created the Youth Preparedness Council (YPC) in 2012 to bring together young leaders who are interested in supporting disaster preparedness and making a difference in their communities, by completing disaster preparedness projects nationally and locally.

YPC members meet with FEMA and other federal staff throughout their term to **provide input** on strategies, initiatives, and projects. YPC members selected during the YPC application period also attend the annual **YPC Summit**.







- The 2021 application period is from <u>January 18 to</u> <u>March 7, 2021 at 11:59 p.m. PST</u>.
- Each year, FEMA's Individual and Community Preparedness Division (ICPD) facilitates the YPC application period to select both National and Regional YPC members. With the FEMA Regions, we:
 - Promote the YPC
 - Review and evaluate applications
 - Interview semi-finalist candidates
 - Select new members for the YPC

Background

ICPD selects the National YPC members, while Regions select their YPC members from the same pool of candidates.

National YPC members are from all over the country.

Applicants that are not selected for the National YPC may be considered for a YPC in their FEMA region.

- The National YPC has 15 members. We will be selecting **eight (8)** new members this year.
- The number of positions available in Regional YPC's varies each year.



Application materials required:


- One (1) online or PDF application form
- One (1) video response (if applicable in place of written narrative responses on the application form)
- Two (2) letters of recommendation
- Academic records (e.g., report card, transcript) from the current (2020-2021) school year (may be unofficial)
- · Academic records from the previous (2019-2020) school year
- Any optional supplemental materials you'd like to provide

Interviewing

 ICPD will notify applicants whether they have been selected for a semifinalist interview in approximately April – May.

■ ICPD and the Regional staff will conduct 30-minute interviews using either Zoom or a phone interview if Zoom is not available.





Notification

- ICPD will send email notifications to non-selected members, semifinalists, and selected members.
- Semi-finalists who are not chosen for the National YPC may be in considered for their Regional or State YPCs.
- ICPD will notify applicants of their decision in approximately May 2021.
