# An Open Letter Appeal to the U.S. Senate Appropriations Committee and House of Representatives Appropriations Committee, to Fund the Low Income Home Energy Assistance Program (LIHEAP) at \$5.1 Billion in Fiscal Year (FY) 2013

June 7, 2012

Dear Members of the Senate and House Appropriations Committees:

We are writing to request that you provide at least \$5.1 billion for the Low Income Home Energy Assistance Program (LIHEAP) in the FY2013 Labor-HHS-Education Appropriations bill. LIHEAP has a vital role in protecting millions of families during both cold winters and hot summers.

Throughout the United States, seniors and families are faced with the day to day struggles of today's economic challenges. From the high cost of medicines to difficulties in the job market, tens of millions of Americans are feeling economic pressures beyond what we have seen in decades. During tough economic times and with home heating and cooling prices on a steady incline, LIHEAP has never been more important for the protection of millions of struggling families.

LIHEAP is an efficient and highly effective program. It delivers critical short-term seasonal aid to our most vulnerable neighbors, especially the elderly, many of whom are on fixed incomes. In addition to its concentration on the elderly, families with small children, and the disabled, studies now show that 20 percent of LIHEAP recipients are veterans; some are even on active duty service to our nation. The increased demand for LIHEAP assistance across the country is undeniable.

In 2008, 33.8 million households met LIHEAP's eligibility requirements. Yet, there was only enough money in the program to serve 5.8 million households. Since 2008, statistics show that wages for working Americans have decreased and unemployment has increased. The worst economic crisis since the Great Depression has put tens of millions of Americans in a desperately precarious financial state. According to the 2010 U.S. Census, 15.1 percent of the nation – over 46 million Americans – are impoverished.

The President's FY2013 budget request proposes to reduce funding for LIHEAP to \$3.0 billion from \$3.47 billion in FY2012. The impact of this proposed cut would be severe. It would compound the effect of cuts from FY2009-10's \$5.1 billion to FY2012's \$3.47 billion. Presently, LIHEAP funding is believed to assist about 8.9 million households or approximately 23 million Americans. Because of this significant cut, States were compelled to make hard decisions: they could cut still more families from the program, or, they could work to hold the number of families assisted relatively constant in the face of overwhelming demand and slash their benefits. In most cases, the latter decision was made. These much-smaller grants to households mean significantly less support is reaching those who are already struggling. Now, the National Energy Assistance Directors' Association, whose members administer the program, is signaling that if the President's request were to become law, more than one million households would likely be eliminated from the program and benefits would be further curtailed. Most of those affected will be elderly, disabled, or, at-risk pre-school children. In addition, states would be hard-pressed to sustain outreach to the temporarily unemployed, including many of our nation's returning veterans.

We urge you to restore LIHEAP funding to at least \$5.1 billion in FY2013. This will allow states and their charitable partners to continue serving some the nation's needlest households within this still-fragile economy and time of unusually high unemployment.
