- Event: Rural Counties Day Reception

Date: March 19, 2025 (March 20 Capitol Courtyard event)

Amount: \$5,000 Signature Sponsorship (top tier)

5 free attendees (cost \$35 each)

Participants: CFEC, Clay, EREC, FKEC, GEC, GCEC, LCEC, PRECO, PowerSouth, Seminole, SECO, SVEC, Talquin, TCEC, WFEC (\$333.33 each co-op, not including any registration fees)

#### Outcome:

- 29 rural counties participated
- Received positive feedback from co-op attendees regarding local county officials and state legislators in attendance



# Proposal 2025/2026 Events

#### **REPEAT EVENTS:**

• Event: Florida Rural Economic Development Summit

Date: November 19-21, 2025

Amount: move up to \$20,000 Rural Champion Sponsor

Reasons:

o 2024 Rural Champions were Duke and FPL

- When we presented the combined sponsorships to our FECA Board, we had a trustee ask why we, the rural co-ops, were not a Rural Champion
- Also increase to a two-page ad and can use the 2025 economic impact data

## • Event: Rural Counties Day Reception

Date: Reception, evening of January 21, 2026 (January 22 Capitol Courtyard event) – this is what we have been told, nothing has been sent out yet

Amount: \$5,000 Signature Sponsorship (top tier)

## **NEW EVENTS:**

• Event: Florida Economic Development Council's (FEDC) Annual Conference - Ignite

Date: 2026 TBD (2025 was May 14-16)

Amount: \$8,000 Gold Sponsorship (amount from 2025)

#### Reasons:

- o Top sponsors in 2025 were Duke and FPL
- A few co-ops already sponsor this event and this give us an opportunity to make
  a larger impact
- Event: FWELF (Florida's Women in Energy Leadership Forum)

Date: 2026 dates TBD (<u>Florida's Women In Energy Leadership Forum – Inform. Inspire.</u> Motivate.)

Amount: \$15,000 Gold Sponsor (amount is from 2025 sponsorship levels)

## Reasons:

- Highest level is Title Sponsors (\$30,000) and from 2024 (not listed yet for 2025)
  they were Duke, Southern Co., FPL, and TECO
- Gold is the next level down
- Largely attended industry event 400 attendees in 2024
- Students studying in industry fields that are "sponsored" to attend event and could be a great HR/hiring opportunity
