Co-ops Will Take Affordability, Reliability Message to EPA Hearings

Next week, G&T cooperatives and NRECA staff will stress the electric co-op message on reliability and flexibility at EPA's public hearings on its <u>draft</u> Federal Plan for complying with the final Clean Power Plan <u>rule</u>. EPA's last three <u>hearings</u> are: Monday and Tuesday, November 16-17, in Denver; Wednesday and Thursday, November 18-19, in Washington, D.C.; and Thursday and Friday, November 19-20, in Atlanta. We'll emphasize that EPA's rule will severely and negatively affect millions of American families and businesses. It will result in higher electric bills and harm the economy in rural America – particularly where people live on fixed incomes or in poverty.

A new National Economic Research Associates <u>report</u> shows the Administration's power plant GHG emissions initiative would result in annual double-digit electricity price increases in 41 states – including many states served by electric co-ops – between 2022 and 2033.

Senate Passes FY16 Appropriations Vehicle, Starts Conference with House

The Senate passed (93-0 vote) an FY16 Military Construction and Veterans Affairs spending bill that will serve as the vehicle for resolving all the outstanding spending bills for the year. The House and Senate have started a conference committee to develop final spending legislation. We're pushing for robust Rural Utilities Service funding, as well as policy riders on EPA and Endangered Species rules.

The House will start its "listening sessions" on the spending bills that failed to get through the House floor. The Agriculture and Interior listening sessions will be held Wednesday. These sessions are intended by Republican Leadership to provide a more transparent process in passing larger pieces of legislation. Congress must complete an appropriations package before the current continuing resolution expires December 11 to avoid a government shutdown.

Senate Highway Bill to Conference; Co-ops Push for House Energy Provisions

The Senate appointed its conferees on the highway bill (H.R. 22), which includes provisions that electric co-ops and other utilities support. We're urging the Senate to accept energy provisions

in the House-passed version, including language that protects utilities from potential Clean Air Act penalties and private citizen lawsuits for voluntary compliance with DOE emergency orders to maintain grid reliability. Other pieces we like exempt critical electric infrastructure information from Freedom of Information Act disclosure, plan for a strategic transformer reserve, and clear authorities for the Secretary of Energy to address grid security emergencies. These elements of the House energy bill (H.R. 8) were added to the highway bill to get them passed this year.

During the conference negotiations, we're trying to get language included that would make EPA's non-hazardous determination on regulating coal ash permanent and put states in the lead on enforcing the regulation.

Some Good News in Final Rule Issued for Tribal Lands Rights-of-Way

There is some good news for electric co-ops in the Bureau of Indian Affairs' (BIA) <u>final rule</u> on rights-of-way across Indian lands, which we expect to be published in the *Federal Register* soon. We're pleased the BIA kept the definition of voltage that avoids service lines being confused with bulk power transmission. We worked with statewides and individual co-ops to urge BIA to ensure that rights-of-way payments for transmission and distribution lines on tribal lands are reasonable.
