FECA's Florida Legislative Report February 23, 2018

This week saw a definite shift in the Legislative Session's tone due to the tragedy at Marjory Stoneman Douglas High School. Students and adults from around the state were at the Capitol engaging elected officials, seeking to ensure student safety.

Even under the somber circumstances, the Senate did convene on the floor and take up their scheduled agenda. Thus, Linear Facilities (HB 405) successfully passed and will be sent to the Governor for final approval. We have added a section in the Legislative Report titled "Governor Action" to track bills that have passed both chambers. Additionally, the State Assumption of Federal Section 404 Dredge and Fill Permitting Authority (HB 7043) successfully passed the House Floor and now awaits its Senate companion to catch up.

The Florida Chamber invited FECA to attend a meeting with EPA District IV Regional Administrator, Trey Glenn and his staff this week. Mr. Glenn mentioned one of his top priorities was showing support of aforementioned legislation, HB 7043. The Administration believes this legislation will allow for a reduction in barriers and delays hindering businesses from growing and succeeding in Florida. He mentioned their continued commitment to addressing WOTUS and CPP.

Below are the current bills of interest that have been filed thus far. Each week, the report will prioritize in the following manner: priority, monitor, and tracking. New bill information (i.e. new committee assignments, companion bills, etc.) can easily be seen in **RED** text. Several bills have been moved to the end of the report due to inactivity. These bills include: Nuclear Cost Recovery, Exempting Renewable Energy Sources from Definition of Public Utility, Energy 2040 Task Force, Energy Grid, and Energy Security and Disaster Resilience Pilot Project. GOVERNOR ACTION

Linear Facilities

(SB 494/HB 405)

Sponsors: Sen. Lee / Rep. Williamson

Summary: This bill is identical to SB 1048 from last Session. The bill died in House Messages last year.

The legislation excludes work by electric utilities on rights-of-way from the definition of "development" under the Florida Local Government Development Agreement Act. This is in response to an adverse decision against FP&L in the Third District Court of Appeals which ruled that under the Power Plant Siting Act, the Siting Board must consider local developmental regulations such as undergrounding when the project includes new transmission lines. This decision adds a new regulatory step to the power plant siting process when new linear facilities are included in the project which unnecessarily adds time and money to the process.

Impact / Importance to Co-ops:

This legislation was filed in response to a ruling by an appeals court and would impact how electric utilities proceed in securing undergrounding and/or transmission lines under the Power Plant Siting Act.

PRIORITY

Medically Essential Electric Utility Service

(SB 1630 /HB 1081) Sponsors: Sen. Hutson/Rep. Perez

Summary:

Under current law only IOUs are required to follow notification and certification requirements relating to medically essential electric utility service & service disconnection. Under this bill, the requirements for medically essential electric service would apply to co-ops and munis as well. It would require emergency management plans to develop an interjurisdictional arrangement in consultation with each utility to identify facilities are deemed to be critical to public health, safety, welfare or security. Emphasizing expeditious restoration of services to the facilities deemed critical during times of disaster.

Impact / Importance to Co-ops:

This legislation would expand the jurisdictional authority of the PSC over co-ops and munis to include requirements and certifications for medically essential electric services.

General Appropriations Act

(SB 2500 /HB 5001) Sponsors: Sen. Bradley/ Rep. Trujillo Summary:

The House bill appropriates \$250,000 to the PSC to study the efficacy and costs of all technically feasible storm hardening measures for the electric power grid. The report would be submitted to the Legislature and Governor by June 1, 2018. The same study language was not included in the Senate Appropriations Bill. However, the language could be added to the Senate bill at any time during the budget negotiations.

The language is vague, but appears to include the co-ops and munis in the study.

<u>Theft</u>

(SB 928/HB 713) Sponsors: Sen. Bracy / Rep. Donalds

Summary:

The theft of utility services is punishable as provided in Section 812.014, F.S. Currently under this Section, a person could be convicted of grand theft and a felony of the third degree if the property stolen is valued at several amounts but the lowest amount is \$300 or more, but less than \$5,000. This legislation would raise the lowest amount for this conviction from \$300 to \$1500 which could reduce the number of eligible convictions for theft of utility services. The House Bill as specifically added theft of electricity as a grand theft and a felony of the third degree.

State Assumption of Federal Section 404 Dredge and Fill Permitting Authority

(SB 1402 /HB 7043)

Summary:

The legislation defines "state assumed waters" and provides that DEP will adopt rules to assume and implement the section 404 dredge and fill permitting program pursuant to the federal Clean Water Act.

Electric Vehicles

(SB 384/HB 981) Sponsors: Sen. Brandes /Rep. Olszewski Summary:

This bill would require the Florida Transportation Commission (FTC) to review all sources of revenue for transportation infrastructure and maintenance projects and when the FTC determines that electric and hybrid vehicles make up over 2% of the total number of vehicles registered in the state, they would submit a report to the Governor and Legislature. The report will assess transportation infrastructure with respect to emergency evacuations to determine the availability of electric vehicle charging stations and other needs throughout the state. The report would make recommendations to the legislature for continued adequate funding for existing infrastructure and for continued growth and improvements in infrastructure and capacity projects for electric vehicle including evacuations.

Disaster Preparedness Tax Exemption

(SB 620/HB 7087)

Sponsors: Sen. Passidomo / Rep. Renner

Summary:

This bill establishes a 10-day sales tax exemption in June 2018 on certain items relating to disaster preparedness and protection. During the exemption period, the following items, will be exempt from state sales and use tax and county discretionary sales surtaxes: certain light sources, radios, tarps, "tie-down" kits, fuel tanks, batteries, first aid kits, cellular telephone chargers, food storage coolers, portable generators, storm shutter devices, carbon monoxide detectors, reusable ice, personal locator beacons, and emergency position-indicating radio beacons

Regional Rural Development Grants

(SB 1646/HB 1103)

Sponsors: Sen. Montford /Rep. Albritton

Summary:

Regional Rural Development Grants may be used to hire regional economic development organization staff; outlines the maximum amount of grant funding for the year; revises required matching funds must be nonstate and equal to 25 percent of the state contribution; expands project eligibility for improving availability for broadband internet service.

Nursing Home and Assisted Living Facilities

(SB 1874/HB ___)

RELATED BILLS: 284, 327, 372, 437, 479, 558, 655, 896, 933, 1260, 1321, 1408, 1444 Sponsors: Sen. Passidomo /____

Summary: There are currently several bills that will address the nursing home power restoration situation in varying manners. It is anticipated that if any action will take place on

this issue, one bill would become the vehicle. Thus, we will monitor for amendments that will merge concepts and ideas into one bill.

Requires each Nursing Homes and ALF facility have an operational emergency power source and fuel to sustain an air temperature set in rule for at least 96 hours. Each facility must have an appropriate transport plan if those safe temperatures cannot be sustained.

OGSR/Local Government Electric Utility

(SPB 7008/HB ___)

Sponsors: Committee Bill Communications, Energy & Public Utilities /Rep

Summary:

This bill is a proposed committee bill and an Open Government Sunset Review issue which evaluates a public records exemption to verify that the exemption is still needed and worthy of the protection under the state. This OGSR allows for proprietary confidential business information held by electric utilities to be exempt from public record requests. Trade Secrets; internal auditing controls and reports; security measures; information concerning bids or contractual data; and information relating to competitive interests are all considered to be proprietary and confidential business information that will be exempt from public record.

NOTE: Upon passage in committee, this bill will receive a new Senate Bill number and a member sponsorship should be assigned.

Exemption of Certain Manufacturing Equipment

(SJR 136 /HJR ____) Sponsors: Sen. Steube/____ Summary: Exempt certain manufacturing equipment from Tangible Personal Property tax or allowing such equipment to be assessed at less than just value through an accelerated depreciation method.

Exempting Renewable Energy Sources from Definition of Public Utility

(SB 292/HB ____)
Sponsors: Sen. Rodriguez /____

Summary:

Exempt certain renewable energy sources from the definition of "public utility" which would make them unregulated by the PSC.

Public Electric Utility Rates

(SB 626/HB ____) Sponsors: Sen. J. Rodriguez /____

Summary:

This bill is identical to SB 976 from last session. Last year, it did not have a companion and was never heard in committee.

Public Utility Environmental Remediation Costs

(SB 656/HB ____)

Sponsors: Sen. J. Rodriguez /____

Summary:

If the Department of Environmental Protection makes a determination that a public utility has caused environmental damage within the state; a municipality or county in which the damage occurred must file a request for a hearing before the Public Service Commission.

Nuclear Cost Recovery

(SB 716/HB 6071)

Summary:

This bill would repeal provisions relating to cost recovery mechanisms for the siting, design, licensing, and construction of nuclear and integrated gasification combines cycle power plants.

Energy 2040 Task Force

(SB 1038/HB 1411) Sponsors: Sen. Brandes / Rep. Diamond Summary:

Creation of an Energy 2040 Taskforce within the PSC to project Florida's Electric energy needs over the next 20 years and determine how best to meet those needs in an efficient, affordable and reliable manner while increasing competition and consumer choice and ensuring adequate electric reserves.

Energy Grid

(SB 1586 /HB____) Sponsors: Sen. Simmons /Rep.

Summary:

Requires the PSC to hold hearings to determine disaster hardening standards for all electric utilities with the goal to have most electricity restored within 24-hours after the storm.

Energy Security and Disaster Resilience Pilot Project

(SB 1888 /HB 1133) Sponsors: Sen. Garcia /Rep. Raschein Summary:

Creates a pilot program within DACS to encourage and demonstrate the effectiveness of distributed energy generation and energy storage technologies to provide for the energy needs in areas of critical state concern during a natural disaster or state of emergency.

CONSTITUTION REVISION COMMISSION

<u>Constitution Revision Commission Proposal – 60% Passage on</u> <u>Constitutional Amendments</u>

(Proposal 97)

Sponsor: Keiser

Summary:

This would require the passage of all Constitutional Amendments to meet a 60% favorable threshold of all voters. If a voter abstains from voting on an amendment, it would qualify as a negative vote.
