The lower performance noted on the rating scale for Site 18 is receiving attention; swift resolution should follow.

#### **General Issues**

Most sites are stable regarding COVID-19 surveillance. We still note some sites with self-serve food options that may result in contamination and exposure potential; specifics are noted in the site updates below.

#### **Additional Considerations**

We are creating and delivering more signage; we will also ensure that Site 18 and Site 19 are COVID-19 compliant today. We will add a trained PC team member for Site 19. We shipped six (6) infrared thermometers with capabilities and accurate performance in humid environments to our team for distribution as needed at the sites. All PC team members received the credentialing documents via cell phone and as a printed copy for display on their vehicle dashboards.

<u>Site 18</u>: The site continues mobilizing and set-up efforts. The teams worked together to remove the tables in the meal tent to handle potential overcrowding - the idea was to mirror Site 8: removing the furniture to minimize the opportunity for closeness. The tent can seat about 25 people with social distancing and they are trying to move many more through. They had a bit of an altercation involving workers who were vying for table space, so the team agreed to try this solution. We will follow-up tomorrow.

Additionally, these updates were considered/implemented:

- The plan is to replace the large buses with trailers, as the buses can only accommodate eight (8) sleepers and the trailers can handle 21. This will also help with overall site space.
- For now, the plan is to leave the fencing in place, since the bus situation will clear out the path into the site somewhat. They
  do have information from a vetted local fencing contractor; if they decide to move the fence, this can be accomplished very
  quickly and replaced when ready.
- They have eight (8) hand washing stations and need ~25; they are working to get the additional stations.
- There were not enough toilets this morning; more arrived at 3:00 pm we will share updates on total delivered.
- The plan for lunches is primarily to-go; supervisors are taking 20+ meals out to their teams, to avoid overcrowding in the one meal tent.
